Annexure-I

TERMS AND CONDITIONS FOR HIRING THE VEHICLE FOR THE PERIOD

From 1st August , 2010 to 31st December, 2011

1. Hired vehicle should be on the basis of **Annexure-I & II**.
2. Consolidated rates will be paid by the University.
3. After finalization of the tender, the tenderer shall be deposited Demand draft amounting to Rs. 10,000/- as performance security from any Nationalized bank in favour of Registrar, LNUPE, Gwalior. The performance security will be released after 90 days of completion period of contract.
4. The following shall be the duty of provider of the vehicle:-
 - 4.1 Entire responsibility of maintenance shall be remained with the provider of the vehicle.
 - 4.2 The responsibility of theft, damage etc. of the rented vehicle lies with the provider of the vehicle.
 - 4.3 The vehicle should be properly maintained and should always contain a stepney. The comprehensive Insurance of the vehicle for the period from 1.8.2010 to 31.12.2011 Should be done.
 - 4.4 It has to be made from authorized Insurance agency under Motor Vehicle Act by the owner of the hired vehicle compulsorily and all legal and mandatory documentation has to be completed by the provider of the vehicle.
 - 4.5 The vehicle always be provided with well trained and experienced driver(s) who should have a valid driving license issued by the competent authority of the state. The salary and all expenses, miscellaneous expenses if any, to be paid to the driver will be borne by the provider of the vehicle only.
 - 4.6 The vehicle would be under the control and instructions of the University vehicle In-charge during the hired period.
 - 4.7 The vehicle should be commercial i.e. registered as 'Taxi' and have a national driving permit issued by the competent authority authorized under the Motor Vehicle Act.
 - 4.8 The driver of the vehicle should ensure that he always keep with him driving license, Insurance Policy inclusive of hired period, registration, pollution certificate and other necessary mandatory documents in original which is required by the vehicle checking authority of the concerning area at any time in accordance with Motor Vehicle Act. In case of non producing of the required documents before the vehicle checking authority under Motor Vehicle Act by the driver and if any penalty is imposed by way of challan or else and/ or any order is passed by the Traffic Magistrate or other authorized officer/ Magistrate of the state against the driver or the provider / owner of the hired vehicle shall not be liable or responsible to adhere of the verdict passed by such authority/ Magistrate or to pay the penalty etc. The solely responsibility and liability will have to be borne by the owner of the hired vehicle by way of abiding the order(s) of the such authority or to pay penalty in case or whatsoever.

- 4.9 If any penalty is imposed by the vehicle checking authority under authorization of the competent authority under Motor Vehicle Act or otherwise any Act due to non-driving at proper side or non-parking vehicle at ear-marked place at the stoppage or any other amount of penalty will have to be borne by the owner or the driver of the hired vehicle. The University shall not be responsible at any stage.
- 4.10 In case of any accident is occur by the negligent driving/ mis-happening whatsoever may be and the liability or responsibility is imposed by the competent authority authorized by the concerning state then whole liability and responsibility will have to he owner of the hired vehicle or driver only. All the legal as well as documentation charges whatsoever may be in regard to the hired vehicle will be borne by the provider of the vehicle.
- 4.11 In case of failure of hired Vehicle, the service provider of vehicle is liable to provide another vehicle immediately. If any other vehicle is not provided ours then proportionate amount will be deducted from the bill of the instant month.
- 4.12 In case of provider does not made available hired vehicle one day then proportionate deduction equal to three days for every one day would be made from the bill of the provider of the vehicle.
- 4.13 The contact is valid for the period from 01.08.2010 to 31.12.2011.
- 4.14 The driver of the vehicle always be in uniform of white shirt, trouser and cap during the duty.
- 4.15 The University reserves the right to terminate or cancel the contract at a notice of three days.
- 4.16 In case of hired vehicle is taken out side from the Municipal area of Gwalior and if any tax is charged at the barrier then the taxes imposed under the authority of the a will have to be borne by the provider of the vehicle only and the University shall not be paid.
- 4.17 In case of any legal dispute between provider of the vehicle and the University, the jurisdiction will be Gwalior only.
- 4.18 In case of any arbitration arises between the University and travel agent/ contractor, the jurisdiction shall be at Gwalior only.
5. The Vehicle will be required from 1.08.10 to 31.12.2011 by the university.
6. The successful tender will have to enter into an agreement on Non –Judicial stamp paper worth Rs.100/- of due performance of the contract.
